- Villa accommodation fees can either be payable by Telegraphic Transfer (an extra \$25 SWIFT bank fee will be
 added on total amount due) or by Credit Card (with an applicable 2.8% Credit card processing fee applied to the
 total amount due).
- We ONLY accept (Visa & Mastercard Credit Cards) You can either call us directly with your C/Card details or simply send your C/card details via 2 separate emails
 - with the 1st email stating: the first 8digits and your expiry date /
 - then send the 2nd email stating: the last 8digits and the card holders name.

**We do not hold Credit Card details once payment has been processed – all data/card information is erased **

- <u>ALL CONFIRMED</u> bookings must be paid prior to guest's arrival i.e., Total Villa Accommodation/s fee balance must be PAID 30 days prior to guest's arrival.
- We also require quests to supply us with (credit card) details upon arrival for coverage against damage and/or loss caused by guests during their occupancy within our property.

CHECK IN:

Check In time: 12.00PM (1200hrs)

EARLY CHECK IN: 50% of the daily rate applies.

Early check in is from 0600am. Check in before this time a full daily rate applies.

CHECK OUT:

Check Out time: 10.00AM (1000hrs)

LATE CHECK OUT:

#1: Late check out is till 1.00pm (1300hrs): 25% of the daily rate applies.

#2: Late check out after 1-6.00pm (1300-1800hrs): 50% of the daily rate applies.

#3: Late check out after 6.00pm (1800hrs) incurs a full daily rate applies

It is recommended that guests arriving before 6.00AM and departing after 6.00PM are booked for an additional night or have early check in/late check out arrangements
